2011-2012 Dependent Verification Worksheet FEDERAL STUDENT AID PROGRAMS

Your FAFSA application was selected for review in a process called "Verification." In this process, the school will be comparing information from your FAFSA application with signed copies of you and your parents' 2010 federal tax forms and W-2 forms or other financial documents. The law says we have the right to ask you for this information before awarding federal aid. If there are differences between your application information and financial documents, corrections may need to be submitted. Complete verification as soon as possible, so your financial aid will not be delayed.

What you should do:

1. Collect you and your parent(s') 2010 financial documents (signed federal income tax forms, W-2, etc.).
2. Forward the completed, signed worksheet, tax forms, and any required documents to the financial aid office.
3. The Financial Aid office will compare information on these documents to your FAFSA and make corrections if necessary.
4. Speak to Student Services if you have questions about completing this worksheet.

Your school must review the requested information, under the financial aid program rules (34 CFR, Part 668).
