

# MONTGOMERY GI BILL ACTIVE DUTY (CHAPTER 30) INCREASED EDUCATIONAL BENEFIT

EFFECTIVE OCTOBER 1, 2011

Educational Assistance Allowance for trainees under the Montgomery GI Bill - Active Duty (Ch. 30 of title 38 U.S.C.). The following basic monthly rates are effective October 1, 2011.

For trainees on active duty, payment is limited to reimbursement of tuition and fees for the training taken.

Educational Assistance Allowance for trainees under the Reserve Educational Assistance Program (Ch. 1607 of Title 10, U.S.C.). The following basic monthly rates are effective October 1, 2011.
